

### SIRTUIN STIMULATION



Stimulation of SIRT1 protein expression versus untreated




Statistical significance vs. untreated \*p<0.05 \*\*p<0.01 vs. placebo ##p<0.01



#### **PROTOCOL**

6 HUMAN SKIN EXPLANTS PER TREATMENT. APPLICATION OF 2  $\mu g$  FORMULATION (PLACEBO AND PRODUCTS). TREATMENT ONCE DAILY ON DAY 0, 1 AND 2. SIRT1 WAS STAINED WITH AN ANTI-SIRT1 POLYCLONAL ANTI-BODY. IMAGE ANALYSIS OF IMMUNOSTAINING OF SIRT1.


